Before enrolling with Driver's Seat, LLC, students under 18 years of age must complete 36 hours of Classroom Driver Education Instruction and provide the DEC-1 Completion Card. Students must also have a valid Learner's Permit with at least 25 hours of driving practice.

For students who obtained a learner's permit at age 18 years and over and have held the permit for 60 days are not required to attend a driver training school to secure a driver's license.

Behind The Wheel Instruction consists of 14- 50 minutes sessions (7 periods driving- 7 periods of observation. On the last session of driving, the student will be given the Virginia State Road Skills Test.

Driver's Seat, LLC provides free pick up from home or school.

The cost for BTW Instruction is \$250 per student. If the student does not pass the Road Skills Test, they will be rescheduled to take the test again at no charge. If necessary, a \$40 fee will be charged for any additional retakes.

Additional lessons of practice training are available at \$45 per hour. Payment is due in full at the time of enrollment. Cash, check, or money order is accepted. A fee of \$45 will be charged for any insufficient funds or stop payment of a check that has been returned by a bank and the issuer will also be responsible for all legal expenses. The student's BTW Instruction will be suspended until payment is rendered in full.

**For Driver Training Schools in Planning District 8, students under age 18 and a parent must participate in an additional 90 minute driver education component that is a requirement of the Driver Ed Classroom curriculum. A completed/signed DTS-90 form is required as proof of completion.**

A refund of all fees paid will be made if Driver's Seat Driving School, LLC is not capable of or willing to start instruction within 30 days of the agreed date in the contract. Refund requests must be submitted in writing.

A minimum of 24 hours advance notice is required for cancellation of the driving instruction. Failure to do so will result in a \$30 fee.

Parents will be notified by phone, email or text message if the school has to cancel and reschedule the lesson.

Driver's Seat Driving School, LLC does not guarantee that any student will pass the state license examination, secure a license or that the student will be guaranteed employment upon completion of the course.
